Thank you for your continued trust and membership in the NDIRF. We look forward to serving you in the years ahead.





**RE: 2026 NDIRF BOARD OF DIRECTORS ELECTION**

Annually, at least two seats on the NDIRF Board of Directors are up for election. The election is held by member voting through solicitation of proxies by mail or voting in person at the NDIRF Annual Meeting. The 2026 NDIRF Annual Meeting will be held at 9:30 a.m. CDT on Thursday, May 7, 2026, at the North Dakota Heritage Center in Bismarck.

Directorships representing the member categories of "Schools," and "Others" are up for election in 2026. The incumbent board members are Sonya Larson, Kidder County School District 1 Business Manager ("Schools"), and Burdell Johnson, Atwood Township Supervisor ("Others"). Larson and Johnson will seek reelection in 2026.

In its December 31, 2023, Report of Examination, the North Dakota Insurance Department recommended that NDIRF adjust its Board composition to better reflect claims activity by creating a process for electing or selecting non-member representatives.

On September 4, 2025, the NDIRF Board of Directors approved an amendment to the Bylaws adding a 10th Board position. Beginning with the 2026 election, this new position will be known as the "At-Large Member." The only requirement for this role is that the individual be a North Dakota resident.

Elected officers or employees of NDIRF members are eligible to serve on the NDIRF Board of Directors. Candidates must represent the member category electing a director each year (for example, "Schools," and "Others" in 2026), with the exception of the At-Large Member, who only needs to be a North Dakota resident and is elected by the entire membership.

Any eligible person who wishes to be considered by the NDIRF Nominating Committee as a director candidate must complete and submit a Candidate Application Form by January 31, 2026.

## WINTER DRIVING SAFETY TIPS

Driving conditions seem to vary every day during North Dakota winters, including snow, ice, or freezing temperatures. Here are simple tips to stay safe when you're out on the road:

### CHECK ROAD CONDITIONS

Use the ND Department of Transportation's ND Roads application to review travel conditions and advisories before your departure. This application is available at <https://travel.dot.nd.gov>.

### SEE AND BE SEEN

Be sure your vehicle is visibility ready by removing snow and ice from its exterior, including headlights and taillights, and checking wiper blade conditions. It is recommended wiper blades be replaced every six months, depending on weather conditions and use.

### CHECK IT OUT, TOP IT OFF

Winter driving often means low temperatures, and sometimes even dangerously low temperatures. Be sure your vehicle is prepared to endure freezing conditions by keeping your fuel tank at least half full, verifying battery health and engine oil conditions, and topping off antifreeze and windshield washer fluids. Be sure to use washer fluid rated for -30 degree weather.

### KEEP EMERGENCY PREPAREDNESS KIT FULLY STOCKED

You never know when an unexpected emergency could occur while you are driving, so be sure your vehicle's emergency preparedness kit includes a properly inflated spare tire, wheel wrench, and tripod jack; jumper cables; tool kit and/or multipurpose utility kit; flashlight and extra batteries; reflective triangles and bright colored cloth to make your vehicle more visible; compass, first aid kit (gauze, tape, bandages, antibiotic ointment, aspirin, blanket, nonlatex gloves, scissors, hydrocortisone, thermometer, tweezers, and instant cold compress); nonperishable high energy foods (unsalted nuts, dried fruits, and hard candy); drinking water; reflective vest; cell phone car charger; fire extinguisher; duct tape; rain poncho; and cold weather items (snow brush, shovel, washer fluid, warm clothing, blankets, and cat litter for traction).

### ADJUST TO CONDITIONS

When you are out on the road, be mindful of the conditions and make responsible driving decisions, including reducing speed, increasing following distance, turning off cruise control, accelerating and decelerating slowly, and keeping your eyes on the road to spot black ice or other obstructions.

# DO NOT SLIP ON SNOW REMOVAL AND FALL INTO A LAWSUIT

Winter is approaching in North Dakota. This means snow and ice will likely accumulate on the sidewalks and steps of courthouses, city halls, and various local government buildings across the State of North Dakota. In general, a political subdivision is not liable for injuries arising from the natural accumulation of snow and ice on sidewalks not abutting political subdivision property. See *Makeeff v. City of Bismarck*, 2005 ND 60, 693 N.W.2d 639. However, the analysis is different when applied to areas abutting property owned by a political subdivision.

The North Dakota Supreme Court addressed this issue in *Makeeff* where the plaintiff slipped on an outdoor stairway leading out of the Bismarck Civic Center at approximately 9:30 or 10:00 p.m. *Makeeff*, 2005 ND at ¶ 2, 693 N.W.2d 639. There was no record of any precipitation falling that day; however, members of the plaintiff's family testified it was foggy and misting. *Id.* at ¶ 4-6. Additionally, there was evidence that "several other persons had been injured that day because of the icy steps." *Id.* at ¶ 26. The City produced evidence that it applied "ice melt" on the stairway at 12:00 p.m. and at 8:00 p.m. earlier that day. *Id.* at ¶ 6. The City claimed it could not be liable under North Dakota law if it did not create an unnatural and unreasonably dangerous condition and even if a dangerous condition existed, it had no prior notice of it. *Id.* at ¶ 9.

The Court disagreed with the City's claim that it was automatically immune from liability under these circumstances. In short, the Court held that since evidence showed it was "overcast and drizzling and the stairway was slippery," Civic Center employees applied "ice melt" earlier in the day, and other individuals also slipped and fell, a jury could conclude the City "had notice of the slippery conditions." *Id.* at ¶ 26. Specifically, the Court held it was proper to consider whether "the City acted reasonably both in its failure to warn and in its maintaining the Civic Center steps in a reasonably safe condition in view of all the circumstances, including the likelihood of injury to another, the seriousness of the injury, and the burden of avoiding the risk." *Id.* at ¶ 27.

Put simply, each slip and fall case will rise and fall on its own set of circumstances. As a political subdivision, you have a responsibility to keep the premises abutting your buildings in a reasonably safe condition. Under the guidance in *Makeeff*, you will be best served by ensuring potentially slippery areas are kept clear of snow and ice to the extent possible. Additionally, you will want to place a sign to notify the public of the potential for slippery conditions abutting your buildings. This is especially true in high traffic areas. Once you become aware of a slippery condition, you need to take steps to mitigate the snow and ice as soon as possible. Also, it is important to document the actions taken to mitigate snow and ice accumulation (i.e. date and time of shoveling, application of "ice melt," placing of a sign, etc. . . .). Keeping records of your efforts to mitigate snow and ice accumulation can be vital in the defense of a slip and fall lawsuit.

While perfection is not the applicable legal standard, you will want to ensure adequate attention is given to snow and ice conditions around government buildings. Additional attention to snow and ice removal can save you from the inconvenience of litigation and preserve taxpayer money.

## MEMBER FEATURE: WEST TRAILL AMBULANCE SERVICE

Mayville-based West Traill Ambulance Service was formed in 1972 and covers medical emergency calls throughout much of West Traill County and Steele County. For decades, team members have worked to be there when medical emergencies occur in their North Dakota communities. The ambulance service prides itself on being on the cutting edge of rural medicine with up-to-date equipment and progressive protocols.

### WEST TRAILL AMBULANCE SERVICE TEAM

Stefan Hofer got his start with the West Traill Ambulance Service nearly 30 years ago. He began his career in 1997 as a driver for the service. After some time, he got his Intermediate Emergency Medical Technician (EMT) certification and eventually worked his way up to his current role of President/Operations Manager. Stefan also got his Paramedic certification in 2002 and his Critical Care Paramedic certification in 2008.

Stefan's small but mighty crew mostly works on a semi-volunteer basis. The team at West Traill Ambulance Service is currently made up of 22 employees, both long-term community residents and Mayville State University students. Student employees are typically employed with the service while they are enrolled in school and leave after they graduate. The long-term resident employees typically work 10 to 15 years or more.

### EMERGENCY SERVICE COVERAGE AREA

In 2024, the service team responded to 458 emergency calls in its coverage area. They also handle many transfers from Stefan's hometown of Mayville to Grand Forks and Fargo. The ambulance service's coverage area includes:

The North Dakota Recreation & Park Association (NDRPA) is holding its 24th annual Certified Playground Safety Inspector (CPSI) Course March 17-19, 2026, in Bismarck.

Participants will learn about the latest developments in playground safety through classroom instruction during this two-day course. Individuals interested in becoming a certified playground safety inspector may take the optional exam on the third day.

Sponsorships from the North Dakota Parks and Recreation Department and the North Dakota Insurance Reserve Fund (NDIRF) make this first-class course possible.

## Scholarships available

Limited scholarships are available to NDIRF and NDRPA members who register for both the course and the exam. The scholarship (\$435 value) will cover the cost of course registration. Members receiving a scholarship pay only \$125 for the exam fee.

The scholarship is limited to three people per agency and distributed on a first-come, first-served basis. If an agency submits more than three scholarship requests, additional requests will be placed on a waiting list to be awarded on a first-come, first-served basis after January 30, 2026.





- **Liability Protection** - Early reporting can help protect your entity from legal complications and preserve defenses on your behalf if needed.

"Awards are given to businesses and instructors that excel in driver safety best practices by offering NSC training courses," said Terry Weaver, NDSC Traffic Safety Program Manager. NDIRF received the Driver Safety Training Award for 788 of its member-employees successful completion of NSC defensive driving courses in 2024. As of November 2025, the number of successfully completed courses is up to 935 and counting.

The NDIRF offers educational opportunities to members as a part of our mission to be the source of risk services for North Dakota political subdivisions. Many of these courses are free to NDIRF members, including the NSC defensive driving course.

"Defensive driving courses are a great risk management tool for any entity," said Corey Olson, NDIRF Director of Member Services. "They assist with making roads safe for our employees, citizens, and students by keeping defensive driving tactics in the forefront of North Dakota drivers' minds."

## NORTH DAKOTA FIREFIGHTER'S ASSOCIATION

In November, the NDIRF team took a field trip for an educational opportunity with the North Dakota Firefighter's Association (NDFA). The NDFA's mission is, "To promote the safety and welfare of the North Dakota Firefighter's Association members through uniform and established training standards." The nonprofit organization was established in 1884 and now supports over 6,000 members by attending and hosting seminars at fire schools in North Dakota.

Our team had the opportunity to do a little training like the firefighters. The demonstration began with a presentation that gave a background of the NDFA and its mission. Then, we toured the facility and learned about several emergency scenarios like burning buildings, vehicles, and grain bin rescues.

Since 2019, NDIRF has been a sponsor of the NDFA's emergency service driving simulators. The NDIRF team took turns testing our emergency vehicle driving skills in the simulators. We learned that we should all stick to our day jobs.
